The volunteer leadership and workers involved in the campaign can be justifiably proud of the extraordinarily fine results of this campaign. The spirit of civic pride generated by their hard work and enthusiasm has pervaded every section and segment of Licking County. This is markedly evidenced not only by the wholehearted financial support as indicated by the large number of contributions, but also by the size of individuals gifts.

However, it is the spirit of independent, unsolicited, volunteer giving on the part of the single individual that best illustrates the degree and extent of their civic pride and enthusiasm for this project. When total strangers made the deliberate effort to locate the Campaign Headquarters and go out of their way to come in, introduce themselves and ask for a pledge card; when a farmer takes his produce to market, and in an exchange of conversation complains that he wants to give fifty dollars to the Campaign but doesn't know who to contact to give it to; when factory workers, who have declined contributions in past solicitations, insist on volunteer payroll deductions so that they may contribute something more than just a "token gift"; when social-service clubs and organizations decide to divert funds already earmarked for their own special projects and give it to the Campaign because they think this project is more *important – such actions dramatize* Licking County's achievements.

## A True Titan of Our Community In Memory of

#### William "Bill" T. McConnell, Trustee Emeritus

William "Bill" T. McConnell passed away on August 14, 2024. With his passing, we said goodbye to not only a trustee emeritus to our organization, but a true titan of our community. Bill had a distinguished career with Park National Bank, rising to the rank of President in 1979, CEO in 1983, and Chairman in 1993, before retiring after 55 years of service.

Bill and his wife Jane led a lifetime of dedicated service to our community. Perhaps the most fervent champions of ensuring advanced education was accessible to all, their philanthropy co-founded A Call to College, an educational access program for Newark City Schools, and established two scholarship funds held at the Newark Campus Development Fund to benefit students attending the Newark campus. Bill had held a leadership position on the Newark Campus Development Fund board of trustees since 1986.

Bill leaves a widely known and highly respected legacy of community service and leadership to many organizations in Licking County, where he served as an inspiration for community members by planting seeds of responsibility regarding service, leadership, and philanthropy. His legacy will be a model of an engaged citizen who worked hard to improve the lives of people in our community, possessed an ethos of service, and challenged local leaders to lead with integrity, grit, and effectiveness.

## Honoring Louella Hodges Reese and a Lifetime of Philanthropy



#### **The Rededication Ceremony**

On July 31st, the community gathered for a ceremonial ribbon-cutting at the rededication for Louella Hodges Reese Hall. Mrs. Reese addressed the crowd, reminding all in attendance of the monumental effort of the original founders of the campus sharing, "You all that were here in the beginning and have been so dedicated with your support to the university... this was an innovative thing, and now it has been going for 60 years. Our future is bright."

Our thanks go out to the original founders of the Newark campus as well as the hundreds of individuals that have supported this most recent endeavor. These generous gifts will enhance student learning, heighten student success, and elevate the student experience for decades to come.

#### **Renaming the Renovated Facility in Honor of Louella Hodges Reese**

The power of education to improve lives has been a driving force behind much of J. Gilbert and Louella H. Reese's philanthropy. Together, the couple supported the construction of nearly every building on the Newark campus. They started the annual tradition of sponsoring the Independence Day concert and fireworks display, bringing together thousands from our community in patriotic celebration. The inspiration behind the Next Generation Challenge Campaign, which raised nearly \$21 million in scholarships for the Newark campus, was a \$10 million challenge match issued by Mr. and Mrs. Reese. Mrs. Reese, herself, spearheaded the

development of COTC's Italian Immersion Program, which provides a fully-funded opportunity for COTC students and students from the town of Reggello, Italy to participate in a global exchange program, partaking in the life-changing experience of a foreign culture, language, cuisine, and customs.

Mrs. Reese's expansive work has continued on after the 2018 passing of her husband. "I almost feel that I have an obligation to keep going, continuing what Gib started. He just always wanted to make Newark and Licking County better, and that's what we are doing."

Together, the couple supported the construction of nearly every building on the Newark campus.

Her commitment to public art is why the Newark campus is home to the largest single collection of Gary Lee Price sculptures in the world. Mrs. Reese's life-long appreciation and passion for public art was sparked on a school field trip to the Granville post office. "I can remember it so well because there were less than 900 people in the town when I was in the school, and our teacher took us on a walk to the new post office that had just been built," she reminisced. "The mural was the biggest painting I had ever seen...It depicted the settlers coming to Granville and clearing the woods so that they could build their log cabins. I appreciated the fact that someone had put a mural in Granville. That was a special thing for our little town."

That spark of inspiration has led Mrs. Reese to dedicate a lifetime to making our community the special place that it is. The renaming of Founders Hall in her honor allows for public acknowledgement and recognition of everything that Mrs. Reese has done for the Newark campus.

"I was able to work through my college time, which allowed me to meet so many people in the community. Those connections were great, and actually introduced me to someone who hired me for my first job after graduation." She eventually transitioned to the Columbus campus to complete her degree in human development and family science.

Kevin, on the other hand, attended Ohio State's Columbus campus to pursue a degree in finance. After completing his undergraduate studies, Kevin completed an accelerated MBA program at Ohio University and then returned to Newark to build his career as a financial planner with Edward Jones Investments.

Their deep-rooted connection to Newark and their belief in the power of education led Kevin and Nicole to recently endow The Kevin and Nicole Cox Scholarship at the Newark Campus Development Fund. This scholarship supports graduates from Licking County high schools attending The Ohio State University at Newark or Central Ohio Technical College. "This is our way of giving back to potentially help a number of students (especially fellow Buckeyes!) for many years to come."

For Nicole, the scholarship represents more than just financial support. It's about fostering a sense of community and opportunity for local students. "The Newark campus is a great option for our local kids, to be able to stay local, work local and then hopefully raise their family and live here as they grow up," she says. "It's important for employers looking for local talent that there are local options."

Kevin and Nicole's dedication to Newark is evident in their day-to-day lives and goes beyond their scholarship fund. "Our community is always striving to better itself, and we're proud to be a part of that," Nicole says. They have been blessed with a good life here, and with welcoming their son Everett this past year, they are proud to forever call this place home. Their shared values of education, community, and philanthropy are the driving forces behind their efforts to make a difference, no matter how small.

Their story is a testament to the enduring power of community and the important role that the Newark campus plays in enriching the lives of its residents. Through their scholarship and their active involvement, Kevin and Nicole are helping to ensure that the next generation of Newark campus students have the support and opportunities they need to succeed.

# A Family Connected by Community



Park National and its associates pledged \$1 million to establish The Park National Bank and Associates' Next Generation Challenge Scholarship honoring William T. and Jane Cook McConnell in support of the Newark campus's Next Generation Challenge Scholarship Campaign. Bill McConnell, chairman of the campaign, and his wife Jane donated another \$1 million. Director emeritus J. Gilbert Reese and his wife Louella matched community gifts up to \$10 million in aggregate. It was the most successful fundraising effort for either institution, raising nearly \$21 million.

Park National Bank was established over a century ago, and continues as a family of community banking teams that deliver an exceptional breadth and depth of resources to individuals and businesses, with a hands-on, personalized approach to service and strong local leadership that invests deeply in the places they live and work. The Newark campus has long been a fixture in our community, so much so that you can find multigenerational stories of families taking advantage of the education it affords our neighbors. This is the case with lan Morehead and his mom, Jenny. Ian, a 2023 Newark Catholic High School graduate, will begin his sophomore year at the Newark campus, pursuing a biochemistry degree with intentions of entering the medical field.

The choice was easy for lan, as he had already weighed the pros and cons of his decision with his parents. After deciding to attend Ohio State, starting at the Newark campus was a logical decision for him. Not only has it been convenient to continue to live at home, but lan has found the smaller class sizes and the personalized relationships he can have with professors to be unmatched benefits.

"I like how the teachers are right in front of you," he shared, "as opposed to going to the Columbus campus where you are in a class of a couple hundred students and you have to talk to the TA instead of the actual teacher."

Jenny Morehead's journey has closely paralleled her son's, albeit a generation earlier. As a student, Jenny transferred to Ohio State Newark after having spent two years at another institution. Originally from Granville, Jenny spent her first two collegiate summers back home, working as a teller at Park National Bank in her hometown. Enjoying her work at the bank and wanting to be home in the community she loved, she made the switch to the Newark campus. Jenny ultimately completed her business degree at the Columbus campus but would have happily continued at the Newark campus if the opportunity had existed when she was attending the university. Ian will also eventually transfer to Columbus to pursue his coursework, but a scholarship he received to attend the Newark campus was key in his decision to remain for the start of his sophomore year. Ian is a recipient of The Park National Bank and Associates' Scholarship honoring William T. and Jane Cook McConnell, a scholarship held at the Newark Campus Development Fund. This particular scholarship brings extra significance as Jenny has continued her career at Park National Bank, currently serving as a Commercial Lender.

"Ian probably doesn't know this... I was asked to be the leader of our task force here at Park to raise the million dollars," reflected Jenny. "That was pretty special that we met that goal."

Jenny contributed to that campaign, creating the scholarship her son would one day go on to receive. Although that campaign has come and gone, Jenny and her husband continue to donate to the Newark Campus Development Fund, most recently supporting the capital campaign to build The John and Mary Alford Center for Science and Technology. "I feel like lan is getting the scholarship and we are sort of paying into it, but that is how you give back," Jenny says. "'Pay it forward' is kind of the motto even though he is receiving the scholarship, we are still paying it forward and hope it will benefit other students and our community."

Over the years, Jenny has seen the campus grow and is amazed by the community support that has made it such a special place. It is a benefit to have such an opportunity close to home, but also a place where students from outside the community may come, see the support from our local community and decide to stay for the great opportunities they come to learn about.

The Newark campus thrives with support from our community. It's a sentiment lan also picks up on. Regarding receiving his scholarship, he says, "It means a lot to me...There are so many scholarships you can receive at Newark—I didn't realize that. It makes me see how close-knit everyone is."
